Announcement of organizational structure and personnel system at Noevir Holdings and of personnel changes at two major subsidiary companies

Following Noevir Co., Ltd. ("Noevir")'s decision to establish a holding company, Noevir Holdings Co., Ltd. on March 22, 2011, directors of Noevir at a Board meeting held on March 4 approved the organizational structure and Board members of Noevir Holdings as well as Noevir's Board members. Board members of Tokiwa Pharmaceutical Co., Ltd., which along with Noevir will become a major subsidiary of Noevir Holdings, were also announced.

1. Organizational structure of Noevir Holdings

The following organizations shall be set up at Noevir Holdings: a "General Meeting of Shareholders," a "Board of Directors," a "Chairman and Representative Director," a "President and Representative Director," a "Board of Corporate Auditors," "Corporate Auditors," and a "Group Executive Council" that will discuss and decide on important matters concerning the conduct of Group business. In addition, the following offices and organizations are being established.

(1) Internal Audit

- Provides internal auditing and strengthened internal controls for Noevir Holdings and its subsidiaries, from an independent standpoint.

(2) Management Strategy

- Plans and monitors performance in overall Group management policy, strategy planning and compilation of medium-term business plans.

- Carries out Group IR activities and Noevir Holdings' PR activities.

(3) Accounting

- Handles Group treasury- and accounting-related services, and supports operating companies.

(4) Human Resources

- Sets policy for human resources planning and work management across the Group, and supports operating companies.

(5) Corporate Affairs

- Plans and monitors Group corporate governance, CSR, compliance, equity and asset management and other general administration, and supports operating companies.

(6) Management Information Systems


- Develops and manages Groupwide IT strategies and systems.

(7) Overseas Operations

- Plans and promotes planning for overseas sales network expansion for Group, establishes and manages affiliated companies, joint ventures and sales distributors, and handles import/export-related services.

(8) Brand Development

- Plans Groupwide brand strategy.
